## Cook Off Rules

1. This will be a cook-off with up to 50 teams.
2. Entries must be paid by Nov 8th. **NO** spots will be held without payment. Payments and placements are first come, first served.
3. All Teams must be setup by 7pm on Friday Nov 11th
4. Move in will start on Friday at 8 am.
5. Meat Check in will be Friday, Nov 11th from 12:00PM (NOON) until 8:00PM.

### NO EXCEPTIONS TO RULES

6. Styrofoam containers will be provided for judging entries with numbered tickets attached.
7. A team will consist of a Chief Cook and up to four assistant cooks. **Space will be assigned as you complete your registration w/ full payment.** Only one car or truck per team is permitted to be parked in your space. Vehicles may not be moved once they are placed due to safety issues.
8. **No power will be supplied. No exceptions.**
9. Fires are not permitted outside of the BBQ pit. (No fire pits allowed)
10. Each cooking team must use its own BBQ pit. Identical entries **WILL NOT** be accepted from the same BBQ pit.
11. Operable Fire Extinguishers are required at each BBQ pit.
12. The Chief cook will be responsible for the conduct of all team members and guests of the team.
13. Most Patriotic Setup Judging –determined by Post 7109 BBQ committee.
14. All food items will be judged Based on the IBCA Bar-B-Que point grading system, which will be explained during contest meeting. This will be explained at the cooks meeting. See IBCA Rules Website [www.IBCABBQ.ORG](http://www.IBCABBQ.ORG)
15. GRAND CHAMPION is based on total accumulation for all 3 entries Meat Categories.
16. The VFW Canteen will sell beer inside of which may be brought outside. Cooking teams are allowed to bring their own beer to be consumed in their BBQ Space only. Beer not purchased in the VFW Canteen cannot be brought into the VFW Post.
