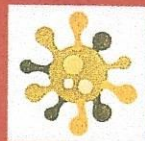

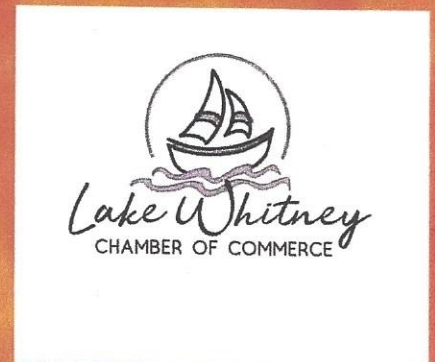

Meat inspection and cook's meeting will be Friday, June 18<sup>th</sup> at 7 pm in the Judges Tent (see rules and regulations for setups). Cooking may begin after check-in. **ATTENDANCE OF THE COOKS MEETING IS MANDATORY.**

**TURN IN TIMES:** Times for each category shall be pre-set. Once the time is set and/or announced, no changes will be made. A turn in window of ten (10) minutes before and after the set turn in times will be recognized. Judging trays received after that time will not be accepted for judging.

<b>Beans:</b>	<b>11:00 on Saturday, June 19</b>
<b>Chicken:</b>	<b>12 noon on Saturday, June 19</b>
<b>Pork Spare Ribs:</b>	<b>1:30pm on Saturday, June 19</b>
<b>Brisket:</b>	<b>3pm on Saturday June 19</b>
<b>Best Pit:</b>	<b>1-2pm on Saturday June 19</b>

**ANNOUNCING WINNERS:** Announcement of the BBQ Cook-off winner will held at the end of the judging. The announcement of winners will be based on the number of competitors in each category. Example: Cook-off with ten or more entries announces the top 10 plus final table (numbers only). It is recommended that more than one person verify ticket numbers.

**PRIZES:** A Grand Champion and Reserve Champion will be named at our cook off. In the event of a tie for Grand Champion, brisket will be the first tie breaker, followed by ribs, then chicken. The promoter **MUST** advertise any changes to the tie breaker decision in advance.

Payout will be 75% to be determined on number of entrants.

Awards will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place in each category.

**No animals of any kind are allowed in the judging area. All animals must be on a leash.**
