# Ingleside Ribs & Rods BBQ COOK-OFF

## Ribs & Rods Rules and Guidelines

1. A contestant or team consists of one chief cook and no more than four assistants. Contestants may check into the barbecue cook-off grounds beginning Friday June 18th at 8:00am until 8:00pm, and must be in place by 8:00am Saturday June 19th. Overnight camping is allowed only on Friday night. You will be assigned a 30x40 space. RV's are allowed, however, hook-ups are un-available. Dumping of tanks are strictly prohibited. You will be provided turn-in trays at the Friday evening Cook's meeting, scheduled for 6:00PM

2. Entry Fees are \$200.00 and covers all meat categories.

3. Any nudity, lewdness, or any form of vulgarity will NOT be allowed. No pyrotechnics, explosives or firearms are allowed. Any intentional use by the team will result in disqualification, and removal from fairgrounds.

4. Music within your team area is allowed. **HOWEVER**, NO excessive loud music and/or sounds which interfere with announcements, schedules, live bands and entertainment on stage, or which intrude upon or interfere with the comfort of fellow contestants.

5. Decisions of the Judges are final.

6. Trophies will be given to 1st - 3rd places in each of the IBCA categories and Grand Champion & Reserve Champion overall. Certificates will be given to 4th and 5th place contestants. Cash prizes for 1st - 5th places in each IBCA meat category (percentage based upon participation).

7. All Jackpot category payouts: 1st place 50%; 2nd place 20%. **CHEF'S CHOICE - You may prepare any dish. No other jackpot category or dessert will be allowed in this category.**

8. Damages/Security/Safety: Teams participating in the contest must not damage in any way the premises on which the contest is being conducted. UNDER NO CIRCUMSTANCES are there to be any stakes driven into the asphalt/concrete or any open fires on the grounds. All fires must be contained in a fireproof container. All drippings from BBQ pit must be contained. Please be sure to bag and dispose of properly. Security and safety are the sole responsibility of each team/contestant. The (Ingleside Ribs & Rods BBQ Cook-Off) Committee is not responsible for any injury to any such person(s).

9. Each team is responsible for ensuring that its space is cleaned following the contest. All trash must be placed in the dumpster provided. All flames and hot coals must be exterminated and disposed of properly. A team may be disqualified from further participation in the contest on any subsequent contest in the event that the team either causes damage to the grounds or leaves its space in disarray or with loose bundled trash or garbage following the contest.

10. Categories for The Ribs & Rods BBQ Cook-Off are:

12:00PM - Chicken (No Cornish Game Hens)

Turn in two halves of a whole fully jointed chicken (half must include leg, thigh, wing and breast portion)

1:30PM - Pork Spare Ribs- **Saint Louis cut is acceptable (SLAB)** (No County Style, Baby Back or Loin Back) Turn in approximately nine individual pork spare ribs, cut apart.

3:00PM - Beef Brisket – Turn in approximately nine slices.

11. Cooked on site: All meat will be brought to the site RAW. No pre-marinating, pre-soaking, or pre-spicing.

12.Sauce: You may COOK with sauce but DO NOT add sauce, marinade, or juice to the meat or container once the meat is prepared for turn-in.

13.Cooks are to prepare and cook barbecue in as sanitary a manner as possible. Cooking conditions are subject to inspection by the Committee. Conditions found to be unsanitary will be grounds for disqualification from the cook-off. At the present time Ingleside has a Burn Ban in effect and we ask for your cooperation in keeping our city safe. No holes, open fires, or dug pits will be allowed. However, a burn-down barrel will be allowed but MUST have some type of safety barrier placed across the top and around the sides of the barrel. Precautions MUST be made to prevent fire threat.

14.Winners will be announced after judging in the BBQ judging area.

15.The Head Cook for each team will be responsible for the conduct of his team, guest, or invitees. As well, the Head Cook will be responsible for this team's compliance with the rules and regulations herein set forth. EXCESSIVE use of alcoholic beverages will be grounds for disqualification. Beer will be sold by Ribs & Rods BBQ Cook-Off Committee. Cases will be sold to contestants at a discounted rate. Teams will not offer Barbecue FOR SALE. Any offensive conduct will be grounds for disqualification from the Cook-Off and expulsion from the Barbecue Cook-Off Grounds.
